Review of material changes

There was no change in the Company's Mineral Resources. The Mineral Resources were upgraded and reported in accordance with JORC Code 2004 in February 2013 and were then reviewed and reported in accordance with JORC Code 2012 in May 2014. There was no material change to the Mineral Resource estimate.

Governance controls

The Mineral Resource estimate has been prepared by a qualified professional following JORC compliant procedures that ensure representative and unbiased samples are obtained with appropriate QA/QC practices in place. The Mineral Resource estimate was independently estimated by CSA Global Pty Ltd in compliance with JORC 2012.

The Company has not estimated any Ore Reserves.
